Mayor Scherer provided a COVID-19 update. He demonstrated the resources available via <u>www.westchestergov.com</u> for current COVID statistics and the new addition of a vaccine dashboard.

Mayor Scherer stated that during the work session included a discussion summer planning for camp and pool. Registration for the pool is anticipated to open the first week of May.
