<u>Public Comment by Bernard Gordon, 17 Brookfied Place, Pleasantville, New York 10570</u>

Mr. Gordon wanted to discuss developments in the R-2A and Special Character Overlay District. 245 Bedford Road was subdivided making two separate lots. Mr. Gordon has asked that the Board of Trustees pass a moratorium on subdivisions of corner lots in the R-2A zone. He feels that there is an urgency for the moratorium because there are possible subdivisions of corner lots in the R-2A zone, particularly the Girl Scout Building. Mr. Gordon feels that if this property is subdivided there will be a negative impact on Great Oak Lane.

<u>Public Comment by Ruth Fischer, 571 Manville Road, Pleasantville, New York 10570</u>

Ms. Fischer wanted to discuss the potential placement of book bins in the Village for recycling. Chappaqua has four book bins that she regularly visits and people spend approximately 5 minutes at the bins. They drop off books or they collect them, then they leave. She believes that Pleasantville would benefit from them.

Announcements:

Mayor Scherer stated that Covid is still around. There are still positive cases throughout the County, there are 32 cases active in the state system but this doesn't account for at home tests.

Regular events are starting to pick back up. In the month of May, the Village will be having Pleasantville Day on Saturday, May 21^{st} and the Memorial Day Parade is on May 30^{th} . The Fire Department will be having their parade June 3^{rd} .

You can download the Recycle Right Westchester App to your mobile smartphone which will give you a notification to let you know when trash pick-up is or if there are special pick-ups.

You can sign up for Grid Rewards through your smartphone. ConEdison will send you a notification when you are overusing your electric and ConEdison will send you check in the mail at the end of the year. There will be letters going out in the mail within the coming weeks from Sustainable Westchester. Trustee Alvarez also mentioned that you can sign up for Grid Rewards for commercial accounts as well. It isn't just for residential accounts.

There will be a public hearing on May 9th for resident to weigh in on the discussion pertaining to leaf blowers.

Trustee Alvarez had a Ribbon Cutting Ceremony at his law firm in the Village. Mayor Scherer thanked the Chamber of Commerce for arranging the ceremonies for businesses.

WHEREAS, as a member of Sustainable Westchester and a participant in the CCA Program, the Village intends to continue to engage the services of Sustainable Westchester as the Program Manager for Community Choice Aggregation for the operation and maintenance of the Program; and

WHEREAS, the Village also is seeking to extend the term of the existing ESA which expires on June 30, 2022, subject to certain modifications, and enter into an extension of the ESA, in the event certain conditions are satisfied.

NOW THEREFORE BE IT RESOLVED, that the Village Board of Trustees of the Village of Pleasantville hereby authorizes the Mayor to execute the Memorandum of Understanding (MOU) with Sustainable Westchester, subject to final review and approval by the Village Attorney as to form and substance, in order to continue to participate in the CCA Program in the Con Edison territory, through an extension of the ESA commencing on July 1, 2022; and

BE IT FURTHER RESOLVED, that so long as the conditions set forth in the MOU are satisfied, the Village Board hereby authorizes the Mayor to sign an Agreement to Extend the Competitive Electric Service Agreement, subject to final review and approval by the Village Attorney as to form and substance.
