1 PCTV Service Agreement: June 1, 2023 - May 31, 2024

- 3 **THIS AGREEMENT** made this 1st day of June, 2023 among and between:
- 4 Pleasantville Community Television, Inc.
- 5 PO Box 426 (2 Lake Street), Pleasantville, NY 10570
- 6 (hereinafter referred to as "PCTV")
- 7 and
- 8 Village of Pleasantville
- 9 80 Wheeler Avenue, Pleasantville, NY 10570
- 10 (hereinafter referred to as "Village").
- In consideration of the covenants and agreements hereinafter set forth, the parties
- 12 agree as follows:
- 13 **1. TERM**
- 14 This Agreement shall begin on June 1, 2023 and continue for a 1-year term, ending on
- 15 May 31, 2024. This Agreement can be terminated with 120 days written notice by either
- 16 party.
- 17 Upon the termination of this agreement, PCTV and the Village shall be relieved of their
- obligations hereunder, except for any monies due to PCTV, which shall be pro-rated
- and paid within thirty (30) days of the termination.
- 20 2. SCOPE OF SERVICES
- 21 The Village hereby retains PCTV to provide Village shows as requested according to
- 22 Exhibit A (attached) PCTV will be responsible for timely production and broadcast of all
- 23 content aired on the government access channels assigned to the Village by its cable
- franchises. PCTV will also make all Village content available for on-demand web access
- 25 at PCTV76.org.
- 26 3. FEES + PAYMENTS
- 27 PCTV fees to the Village for services rendered pursuant to this Agreement shall be as
- 28 follows:
- 29 YEAR 1: June 1, 2023 May 31, 2024: \$100,000

- 31 In March 2024, the Village and PCTV will review the results of PCTV's operations and
- will consider fee increases, above the base fees in this agreement, for the following
- fiscal year. The Village shall consider fee increases prior to March 2024 based on
- 34 operational performance and need of PCTV.
- In addition to the service fees outlined above, the Village will make the following annual
- 36 payments to PCTV:

- 37 Insurance Premiums: \$5,600, for the (1) contract year.
- 38 Contribution to Shared Website (pctv76.org): \$2,800, for the (1) contract year.
- 39 Payments due PCTV for the fiscal year, per Section 3, shall be within thirty (30) days of
- 40 receipt of an invoice from PCTV, dated not earlier than June 1 of the relevant year.

41 4. REPORTING

- 42 PCTV shall provide the Village with quarterly financial and operation reports in
- 43 September, December, March and June of each contract year. These reports shall
- include detail entries on fiscal year-to-date revenues, expenses, cash balances, and
- 45 updates regarding revenue goals and initiatives. In June of each contract year, PCTV
- shall provide the Village with the same report, based on fiscal year-end.

47 5. PEG PAYMENTS FROM CABLE FRANCHISE HOLDERS

- In accordance with its cable franchise agreements, the Village shall pass-through to
- 49 PCTV any public access "PEG" payments received from its cable franchise holders.
- 50 These monies will be paid to PCTV within thirty (30) days of receipt from a cable
- 51 franchise holder.

52 6. RELATIONSHIP OF THE PARTIES

- The parties hereto do not intend to form a partnership or an employee/employer
- relationship for any purpose including, without limitation, Federal income tax purposes.

55 7. GENERAL PROVISIONS

- a) Each party represents to the other that it has the power and authority to execute and
- 57 deliver this agreement and to perform its obligations hereunder. Each party further
- 58 acknowledges and confirms that it understands the terms and conditions of this
- 59 agreement and that it has freely, knowingly and voluntarily executed this agreement.
- (b) Each party specifically acknowledges and agrees that it is not relying upon any
- representations made by any other party or their respective agents in connection with
- the making and execution of this agreement except as may be otherwise set forth
- herein. Each party to this agreement has reviewed this agreement. The rule of
- construction that any ambiguities are to be resolved against the drafting party shall not
- be employed in the interpretation of this agreement.
- 66 (c) Notices given under this agreement shall be effective only if in writing and if
- 67 delivered personally, OR if mailed by registered or certified mail, return receipt
- requested, and if properly addressed, OR if sent by a reputable, commercial courier
- 69 such as Federal Express.

70 71	(d) This agreement shall be binding and inure to the benefit of the parties. This agreement may not be changed orally or assigned.	
72 73 74 75	(e) The terms and conditions of this agreement shall supersede all prior negotiations, discussion, undertakings and representations of any kind whatsoever, whether written or oral, heretofore made, all of which are merged herein. This agreement constitutes the full agreement of the parties.	
76 77 78 79	(f) This agreement shall be governed by and construed in accordance with the laws of the State of New York. Any disputes regarding or arising under this agreement shall be resolved in any court of competent jurisdiction located in Westchester County, New York.	
80 81 82 83 84	(g) If any provision of this agreement, or the application of any provision to any person or circumstance, shall be invalid or unenforceable, neither the balance of this agreement nor the application of the provision to other persons or circumstances shall be affected. Each provision of this agreement shall be valid and shall be enforced to the fullest extent permitted by law.	
85 86	(h) This agreement may be executed in several counterparts and by facsimile signature all of which shall constitute but one and the same instrument.
