All meetings are held at Village Hall, 80 Wheeler Avenue, 2nd floor unless otherwise noticed. The Board of Trustees will meet on Wednesday, December 27th at 9:00am for the purpose of paying bills. Mayor Scherer advised that the Board met with members of the Recycling Committee to discuss their proposal for a "Plastic Bag Initiative"; the initiative would ban single use plastic bags under most circumstances. Mayor Scherer advised that a Public Hearing will be scheduled in January regarding this issue; more information regarding this proposal is on the Village's Web-Site (www.pleasantville-ny.gov).

Mayor Scherer advised that last week the Board held the second work-shop regarding the "Memorial Plaza Civic Space" project; the complete presentation can be seen by logging onto the Village's Web-Site (www.pleasantville-ny.gov and clicking onto PCTV). Mayor Scherer explained that the Village received a grant from New York State for \$1.5 million; with a \$750.000 matching fund from the Village for a project that incorporates the civic space at Memorial Plaza as well as various street-scape and pedestrian improvements along Manville Road between Grant Street and Tompkins.

Trustee Asquith advised that the Village Board has taken a "Climate Smart Community Pledge" which expresses the Village's intention to become certified as a "Climate Smart Community". Trustee Asquith advised that one of the tasks were to establish a "Community Task Force" and please to advise that the "Community Task Force" held its first meeting this past week; it went very and we look forward to moving forward with this project. Trustee Asquith added that because the Village is part of a "Community Choice Aggregation"

plan for our energy through "Sustainable Westchester"; individual homeowners can opt for green energy by logging onto Westchesterpower.org and opting for for the green energy option.

Mayor Scherer advised that the cost of an all green option as compared to the mixed source option is still less than what the average Con-Edison bill was for the "look back period" and the great news about "Community Choice Aggregation" is that you can opt to an all green plan and build more demand for sustainable energy at little or no economic impact.
