Mayor Peter Scherer mentioned that there was an election last week (Tuesday, March 19, 2024). He was running for Mayor unopposed, David Vinjamuri and Yemi Healy won for Trustee. Yemi will be taking over for Michael Peppard. He thanked the public for voting.

Pleasantville lost Sal Arcidiacono, otherwise known as Sam Archie. He founded Archie's Supermarket, Archie's Corner Store and owned a bit of real estate throughout the village.

Saturday, March 16th was the Village's 127th birthday.

The egg hunt was rained out on March 23rd so it has been rescheduled for March 30th.

May 18, 2024 is Pleasantville Day.

The Pleasantville Music Festival is Saturday, July 13, 2024. Tent City sales are April 13, 2024. Northwell Health will be sponsoring the Festival again.

Westchester Municipal Officials Association has been following what is happening in Albany. The Senate and Assembly proposed a modest increase

in AIM Funding which is for municipalities. New York Conference of Mayors is trying to guarantee increased funding over the years. AIM funding is being increased for the first time in 16 years.

Presentation of FYE2025 Tentative Village Budget:

Village Administrator, Eric Morrissey presented the Village Tentative Budget for the fiscal year ending May 31, 2025. He stated that the FYE2025 budget comes in under the permitted tax cap. The proposed General fund budget is \$25,587,965. The proposed Water Fund budget is \$4,048,162. The proposed Refuse budget is \$1,183,935. A Public Hearing on the Tentative Budget is scheduled for Monday, April 8, 2024 at the regular Village Board meeting.
